#### **GNODI NODE PURCHASE AGREEMENT**

This Gnodi Node Purchase Agreement (the "Agreement") is made and entered into by and between Cirrus Networks ("Seller"), acting on behalf of the Gnodi Consortia DAO, and the undersigned Buyer. This Agreement outlines the terms and conditions governing the purchase, ownership, and operation of a Gnodi Node, a software component that contributes to the functionality and security of the Gnodi Blockchain network.

### **RECITALS**

WHEREAS, Cirrus Networks is a provider of decentralized infrastructure services and offers Gnodi Nodes for those seeking to contribute to the Gnodi Blockchain network; and

WHEREAS, the Buyer desires to purchase a Gnodi Node from Cirrus Networks, and Cirrus Networks agrees to sell the Gnodi Node under the terms outlined in this Agreement.

NOW, THEREFORE, in consideration of the mutual covenants and promises contained herein, the parties agree as follows:

#### 1. DEFINITIONS

- Gnodi Node A software component that contributes to the decentralized operation of the Gnodi Blockchain by processing transactions, securing the network, and maintaining blockchain integrity.
- **Purchase Price** The agreed-upon amount to be paid by Buyer to Cirrus Networks for the Gnodi Node(s).

### 2. GNODI NODE TERMS

- The Gnodi Node is a participation tool in the Gnodi Blockchain, designed to contribute to decentralization and network security.
- Gnodi Nodes are not investment products, and no guarantees are made regarding potential digital rewards.
- The performance of a Gnodi Node depends on various external factors, including network activity, governance decisions, and blockchain protocol changes.

### 5. BUYER RESPONSIBILITIES

Buyer agrees to:

- Operate the Gnodi Node according to the guidelines and best practices outlined by the Gnodi Blockchain network.

- Cover any applicable fees, including but not limited to, maintenance, transaction, and operational costs.

This Agreement may be terminated under the following conditions:

- If either party breaches a material term and fails to remedy such breach within 30 days of written notice.
- If either party becomes insolvent or subject to liquidation.

Upon termination, the Buyer must immediately cease using the Gnodi Node, and any outstanding fees become due.

## 9. LIMITATION OF LIABILITY

To the fullest extent permitted by law, Cirrus Networks shall not be liable for:

- Any indirect, incidental, or consequential damages arising from the use or failure of the Gnodi Node.
- Any loss of digital rewards, network disruptions, or changes in blockchain protocol affecting performance.

### 10. GOVERNING LAW AND DISPUTE RESOLUTION

- This Agreement shall be governed by the laws of Utah.
- Any disputes arising from this Agreement shall first be resolved through mediation before escalating to formal legal proceedings.

### 11. ACKNOWLEDGEMENTS AND RISKS

By purchasing a Gnodi Node, Buyer acknowledges and agrees to the following:

### **General Blockchain Risks**

- Non-refundable Purchase: All Gnodi Node purchases are final and nonrefundable.
- **Market Volatility**: Blockchain networks are subject to high volatility, regulatory shifts, and evolving governance structures.
- **Evolving Technology**: The Gnodi Blockchain may undergo protocol changes that could affect Gnodi Node operations.

# **Digital Rewards – Limitations and Risks**

- **No Guarantee of Digital Rewards**: Operating a Gnodi Node does not guarantee the receipt of digital rewards.
